75% of each contribution to DJTP, to be designated toward either its 2020 primary (which shall be the default) or 2020 general election account, up to a maximum of \$2,800 (\$5,000) per account. 25% of each contribution to the RNC's Operating account, up to a maximum of \$35,500 (\$15,000).

Notwithstanding this allocation formula, a contributor may designate a contribution for a specific participant or participants. In addition, the allocation formula may change if any contribution would exceed applicable contribution limits.
